

CHARTER ORDINANCE NO. 11

A CHARTER ORDINANCE OF THE CITY OF MERRIAM, KANSAS, REPEALING CHARTER ORDINANCE NO. 3.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MERRIAM, KANSAS:

SECTION 1. That Charter Ordinance No. 3 should be and is hereby repealed.

SECTION 2. TAKE EFFECT. This ordinance shall be published once each week for two consecutive weeks in the official City newspaper and shall not take effect until sixty (60) days after its final publication.

A two-thirds vote of the members-elect of the Governing Body of said City shall be required for passage.

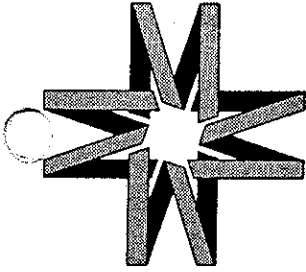
